## RIGHT OF WAY AND EASEMENT GRANT

DONALD E. MAC CARTLE and ELEANOR B. MAC CARTLE, his wife, Grantors of Salt Lake County, State of Utah, do hereby convey and warrant to MOUNTAIN FUEL SUPPLY COMPANY, a Corporation of the State of Utah, Grantee, its successors and assigns, for the sum of One and No/100 Dollars (\$1.00) and other good and valuable considerations, receipt of which is hereby acknowledged, two rights of way and easements, each eight feet in width, to lay, maintain, operate, repair, inspect, protect, remove and replace pipe lines, valves, valve boxes and other gas distribution facilities through and across the following described land and premises situated in the County of Salt Lake, State of Utah, to-wit:

The land of the grantors, Donald E. MacCartle and Eleanor B. MacCartle, his wife, located in part of the northeast quarter of Section 1, Township 3 South, Range 1 West, Salt Lake Base and Meridian.

The center line of said rights of way and easements shall extend through and across the above described land and premises as shown in red on attached Mountain Fuel Supply Company drawing No. 3255, referred to and incorporated herein by reference.

TO HAVE AND TO HOLD the same unto the said MOUNTAIN FUEL SUPPLY COMPANY, TO HAVE AND TO HOLD the same unto the said MOUNTAIN FUEL SUPPLY COMPANY, its successors and assigns, so long as such pipe line or lines, valves or valve boxes and other gas distribution facilities shall be maintained, with the right of ingress and egress to and from said rights of way to maintain, operate, repair, inspect, protect, remove and replace the same.
