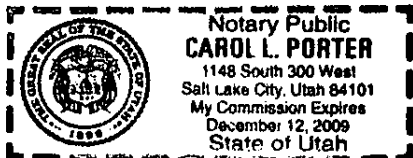

PARCEL 2:

Lots 20 and 21, Block 5, SOUTH BOULEVARD, according to the official plat thereof, as recorded in the office of the Salt Lake County Recorder.

LESS AND EXCEPTING therefrom that portion of the herein described property contained within a parcel of land granted to the State Road Commission of Utah by instrument recorded January 7, 1943 as Entry No. 944011 in Book 333 at Page 78 of Official Records, said parcel of land being 41 feet wide, 41 feet on the South side of the following described centerline:

BEGINNING at the intersection of the East boundary line, produced of said Lot 21 and said center line of survey at Engineer's Station 6+44.5, which point is 152.2 feet South 89°58'51" East along said center line of survey from the city monument at the intersection of Twenty-First South and West Temple Streets; thence North 89°58'51" West 50 feet to the intersection of said center line of survey at Engineer's Station 6+94.5 and the West boundary line produced of said Lot 20, which point is 102.2 feet South 89°58'51" East along said center line of survey from said city monument, as shown on the official map of said project on file in the office of the State Road Commission of Utah.
