Ten Dollars, in consideration of which I hereby grant unto said Company, its successors and assigns, the right to construct, operate and maintain its lines of Telephone and Telegraph, including the necessary poles, wires and fixtures over, upon and along the public roads, streets and highway on or adjoining the property, owned by me, in following:

Beginning at a point on the east line of the State Highway 2542.7 ft N 89° 52' E and 190.5 ft N 21° 52' east of the south ¼ corner of section 1 Township 1 North, Range 1 West S L B M, thence S 69° 43' E 315 ft; thence N 33° 37' E 47 ft; thence N 22° 46' E 81ft; thence N 69° 43' west 331 ft; thence S 21° 52' W 125.4 ft to beginning. County of Davis and State of Utah with the right to permit the attachment of the wires and fixtures of any other Companies, and with the further right to overhang said property with crossarms, wires and other fixtures, and to trim any trees along said lines so as to keep all wores cleared at least forty-eight inches.

Provided further that the two trees shall be moved to new location and if said trees die within one year from date they shall be replaced at the Telephone Company's expense; said trees shall be moved by Mr. Smith of Smith Bros, nursery.

Said sum being received in full payment therefor.
