# WARRANTY DEED



TOGETHER with all improvements and appurtenances thereunto belonging.

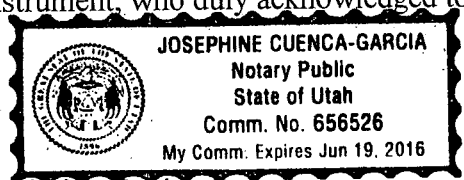
