FIRST AMENDMENT TO DECLARATION OF
COVENANTS, CONDITIONS AND RESTRICTIONS AND
RESERVATION OF EASEMENTS FOR HIDDEN OAKS, INC.

THIS Amendment is made this 27th day of June, 1981, by J. L. ADAMSON & SONS, INC. (hereinafter referred to as "Declarant") and HIDDEN OAKS HOMEOWNERS ASSOCIATION (sometimes also referred to as "Hidden Oaks, Inc."), a Utah nonprofit corporation (hereinafter referred to as the "Association"), and has reference to the following facts:

A. Declarant, as the owner of certain real property located in Utah County, State of Utah (which property is more particularly described in Exhibit "A" attached hereto and by this reference incorporated herein), caused a certain Declaration of Covenants, Conditions and Restrictions and Reservation of Easements for Hidden Oaks, Inc. (hereinafter referred to as the "Declaration") to be prepared, executed and recorded June 11, 1979, as Entry No. 22330 in Book 1751 at Page 271 of the Official Records of Utah County. It was intended that said Declaration, in addition to establishing, covenants, conditions and restrictions for Phase 1 of Hidden Oaks, Inc., a planned unit development, would also permit Declarant to add additional phases to Hidden Oaks, Inc., without obtaining the prior consent of the Association, its board of directors or members. Through a clerical error, however, the legal descriptions of the additional phases to be so added by Declarant were omitted from said Declaration.

B. Declarant and the Association now desire to amend said Declaration so that it will describe the additional phases which may be added by Declarant to Hidden Oaks, Inc., and to further facilitate the addition of said phases.

NOW, THEREFORE, the parties hereto do hereby agree to amend said Declaration, and said Declaration is hereby amended, as follows:

1. The second sentence of Recital D on Page 1 of the Declaration, recorded in Book 1751 at Page 271 of the Official Records of Utah County, is amended to read as follows:

"Declarant may execute, acknowledge and record one or more Supplemental Declarations affecting solely a "Phase" (as such term is hereinafter defined), so long as owners of the affected Phase or any portion thereof join with Declarant in such Supplemental Declaration.

2. The last two lines of Page 6 of said Declaration, recorded in Book 1751 at Page 276 of the Official Records of Utah County, are amended to read as follows: "Section 1. Owners' Easements of Enjoyment. Every owner, including owners of lots in real property annexed within the general plan and scheme of this Declaration pursuant to Article XV hereof, shall have a right and easement of ingress and egress and of . . ."

3. The first sentence of Subsection (e) of Section 12, Article X of the Declaration, which appears on Page 29 thereof, recorded in Book 1751 at Page 299 of the Official Records of Utah County, is amended by deleting therefrom the words "at any time prior to acquisition of title to a lot in a Phase by a purchaser from Declarant, to establish on that Phase . . ." and substituting therefor the words "from establishing on a Phase . . ."

4. Section 1(a) of Article XV of the Declaration, which appears on Pages 39 and 40 of the Declaration, or Book 1751, Pages 309 and 310 of the Official Records of Utah County, is amended to read as follows:

Section 1.(a) Additions by Developer. If Declarant, its successors or assigns, shall develop, or cause to be developed additional real property (Annexed Property) within the area located in the County of Utah, State of Utah, which is more particularly described in Schedules I(A) or I(B), which are attached hereto and by this reference incorporated herein, declarant or its successors or assigns shall have the right from time to time to add such Annexed Property or any portion or portions thereof to the Properties and to bring such Annexed Property within the general plan and scheme of this Declaration without the approval of the Association, its Board of Directors, or Members; provided that such a right of Declarant and its successors

and assigns shall terminate five (5) years from date of recording this Declaration.

5. The Declaration is further amended by adding thereto as Schedule I(A) the legal description attached hereto as Exhibit "B", and by adding thereto as Schedule I(B) the legal description attached hereto as Exhibit "C".

The Association hereby represents and certifies that this Amendment has been approved by the affirmative vote or written consent of the owners holding not less than seventy-five percent (75%) of the voting power of each class of members of the Association and has received the prior written approval of at least seventy-five percent (75%) of all first mortgagees, as required by Section 5 of Article XVI of the Declaration.

The Association further represents and certifies that any approval of the FHA or VA required for this Amendment of the Declaration has been obtained. This Amendment has also been approved by the City of Highland, as evidenced by the attached certificate which is incorporated herein.

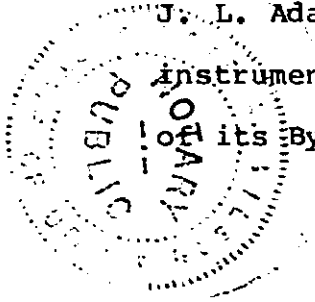

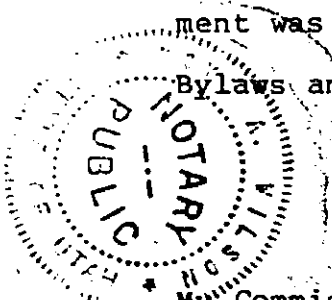
