5' wide permit area, 2.5 feet on either side of the centerline description below, located in the SW½ of Sec. 5, Township 1 South, Range 1 East, Salt Lake Base and Meridian. Beginning at a point on the westerly line of a 66 foot wide Right-of-Way for the Jordan Salt Lake City Canal of the Jordan and Salt Lake City Canal Company, said point lies 55.18 feet S. 00°01'05" W. along the centerline of 900 East and East 85.17 from the Centerline Intersection Monument at 500 South and 900 East Salt Lake City, UT; thence East 71.47 feet to the easterly line of said 66 foot wide Right-of-Way.
