The following is a description of the property so ordered and condemned as hereinabove provided, which is hereby vested in fee simple title in the plaintiff, all of such property being situated in Salt Lake County, State of Utah, and is more particularly described as follows:

Parcel No. 0144:1B:A

A parcel of land in fee for an expressway known as Project No. 0144, being part of an entire tract of property situated in SW(SE) of Section 3, T. 2 S., R. 1 W., S.L.M. The boundaries of said parcel of land are described as follows:

Beginning at a point 75.0 ft. N. 0° 03' 15" W. from the Sk corner of said Section 3; thence N. 0° 03' 15" W. 649.523 ft.; thence E. 59.0 ft. along the north boundary line of said entire tract of property; thence S. 0° 03' 15" E. 549.523 ft. to point "A"; thence S. 0° 03' 15" E. 99.0 ft.; thence M. 89° 56' E. 348.21 ft.; thence S. 31° 30" E. 1.17 ft. to point "B"; thence S. 89° 56' W. 407.817 ft. to the point of beginning. Above described parcel of land contains 0.89 acre, more or less, of which 0.49 acre, more or less, is now occupied by the existing highway. Balance 0.40 acre, more or less.
