The line to run a total of 280 feet M or L. Width of easement to be 5 feet each side of center line of pipe.

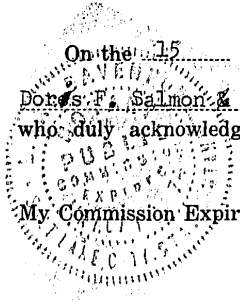
