At a public meeting held on Thursday, 26 June 2014, the Department of Community Development approved a conditional use permit to operate a manufacturing, fabrication, assembly, processing, and packaging business for the property located at 3028 South State Street, with the following conditions:

- 1. The applicant will prohibit any idling trucks that are associated with their business along the public road, White Place so as to mitigate any nuisance that distribution trucks may have on the surrounding single family homes.
- 2. If not already in existence the applicant will provide a waste container enclosure for the business per chapter 17.06.140 of the South Salt Lake City Municipal Code,
- 3. The applicant will continually meet all Salt Lake County Ordinances and Salt Lake County Health Department regulations, including those of noise levels.
- 4. The applicant will meet with the South Salt Lake Fire Marshal and South Salt Lake Public Works Inspector to ensure that all regulations are being met and so as to property mark fire lanes to prohibit any parking that could occur in those areas.
- 5. Signs are not approved with the Conditional Use Permit. Any future signage requires a separate sign permit to be issued by the Community Development Department.
- 6. The applicant shall continually provide sufficient off-street parking for the use and will provide an updated parking lease that will include a minimum of 4 parking stalls designated for the proposed business. If an additional renter moves into the building, parking will need to be reassessed prior to the renter's business license approval. Parking shall meet the requirements of the South Salt Lake Municipal Code.
- 7. All other items of the staff report.
