his wife, Grantor.s., of Utah County, Utah, do hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission, distribution, telephone and telegraph circuits of the Grantee, and two two pole towers and no guy anchors with the necessary guys, stubs, cross arms, braces and other attachments affixed thereto, for the support of said circuits, on, under, over, through, and across a tract of land fifty (50) feet in width, located in Utah County, Utah, and being twenty-five (25) feet on each side of the following described center line:

Beginning at fence on west boundary line of Grantor's land at a point 1500 feet north and 2220 feet west, more or less, from the east quarter corner of Section 27, T. 5 S., R. 1 E., S.L.B. & M., thence running S. 65°19' E. 1397 feet to fence on south boundary line of said land and being in the NW 1/4 of the NE 1/4 and the S 1/2 of the NE 1/4 of said Section 27.
