Beginning at the south boundary fence of the Grantors' land at a point 720 feet north and 812 feet east, more or less, from the southwest corner of Section 24, T. 2 S., R. 1 W., S.L.M., thence N. 20° 46' E. 2.3 feet, thence N. 25° 04' E. 510 feet, more or less, to the north boundary line of said land, and being in the SW 1/4 of the SW 1/4 of said Section 24.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
