~~his wife~~ Grantor, of Salt Lake County, Utah, hereby convey ~~and warrants~~  
to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns,  
Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement  
and right of way for the erection and continued maintenance, repair, alteration, and replacement  
of the electric transmission, distribution and telephone circuits of the Grantee, and  
~~no guy anchors and one pole towers or poles~~ with the necessary guys, stubs, crossarms and  
other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and  
maintained upon and across the premises of the Grantor, in Salt Lake County,  
Utah, along a line described as follows:

Beginning on the south boundary line of the Grantor's land at a point 1172 feet  
north and 1020 feet east, more or less, from the southwest corner of Section 24,  
T. 2 S., R. 1 W., S.L.M., thence N. 25° 04' E. 190 feet, more or less, to the  
north boundary line of said land, and being in the W 1/2 of the SW 1/4 of said  
Section 24.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
