Greenfield and Afton Greenfield, his wife; Eleanor Greenfield Winberg, a woman; Laura Greenfield Atkinson, a woman; Mary Greenfield Palmer, a woman; Edna Greenfield Smith, a woman, Grantors of Salt Lake County, State of Utah, do hereby convey and warrant to MOUNTAIN FUEL SUPPLY COMPANY, A Corporation of the State of Utah, Grantee, its successors and assigns, for the sum of ONE DOLLAR(\$1.00) and other good and valuable considerations, receipt of which is hereby acknowledged, a right of way and easement to lay, maintain, operate, repair, inspect, protect, remove and replace pipe lines, valves, valve boxes and other gas transmission and distribution facilities (hereinafter collectively called "facilities") said right of way being situated in the County of Salt Lake, State of Utah, and more particularly described as follows, to-wit:

Beginning at a point on the East line of North Main Street (Midvale), said point being 201.3 feet South and 33 feet East from the Northwest corner of the South half of the Southwest quarter of Section 24, Township 2 South, Range 1 West, Salt Lake Base and Meridian, thence North 88° 34' East 574.2 feet along Grantors' South line, thence North 1 rod, thence South 88° 34' West 574.2 feet to the East line of said Street, thence South 1 rod to the point of beginning.
