### NOTICE OF CREATION OF PUBLIC INFRASTRUCTURE DISTRICT, PROPERTY TAX LEVY AND INFRASTRUCTURE FINANCING

Notice is hereby given that the City of Payson, Utah (the "City") created Red Bridge Public Infrastructure District No. 1 (the "District"). The boundaries of the District are described in Exhibit A hereto. A copy of the Governing Document for the District is on file at the office of the City. The District may finance and repay infrastructure and other improvements through the levy of a property tax. The maximum mill levy of the District to repay such financing ("Limited Tax Bonds") is 10 mills. Without any further election or consent of property owners or registered voters, the District may convert any Limited Tax Bonds to a general obligation bond if the principal amount of the Limited Tax Bonds together with the principal amount of other related outstanding general obligation bonds of the District does not exceed 15% of the fair market value of taxable property in the District.


