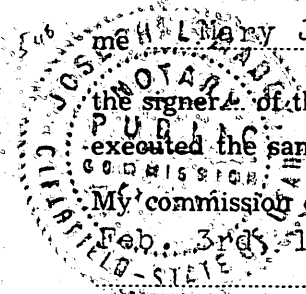

Beginning on east boundary line of Grantor's land at a point 1385 feet south, more or less, from the north quarter corner of Section 33, T. 4 S., R. 1 E., S.L.B. & M., thence running S. 88°58' W. 1320 feet, more or less, to fence on west boundary line of said land and being in the SE 1/4 of the NW 1/4 of said Section 33. Also beginning on east boundary line of Grantor's land at west fence of County Road at a point 1380 feet south and 33 feet west, more or less, from the northeast corner of Section 32, T. 4 S., R. 1 E., S.L.B. & M., thence running S. 88°58' W. 278 feet to existing pole line over said land and being in the SE 1/4 of the NE 1/4 of said Section 32.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation, or enjoyment of this easement.

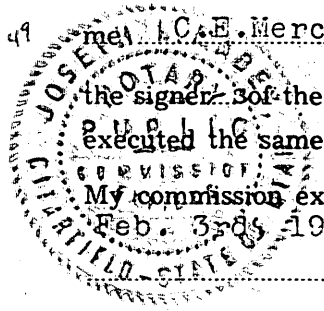
