AN ORDINANCE

AN ORDINANCE VACATING Grant Street (760 West) south from 1700 South Street.

Be it ordained by the Board of Commissioners of Salt Lake City, Utah:

SECTION 1. That Grant Street (760 West) south from 1700 South Street, more particularly described as follows, be, and the same hereby is, vacated and declared no longer to be public property for use as a street, avenue, alley or pedestrian way:

Beglinning at a point S.0°00'15" E. 5.833 feet and N.8°5'3'9" E. 312.00 feet from the N.W. cor. of Lot 12. Block 2, S-Acre Plat "B", Big Field Survey, and running thence S.0°00'15" E. 446.209 feat; thence Southeasterly along a 15.047 foot radius curve 247.84 feet; thence I southeasterly along a 50.00 foot radius curve 247.84 feet; thence I southeasterly along a 50.00 foot radius curve 247.84 feet; thence N.0°00'15" W. 446.207 feet; thence I seement for the construction, maintenance, replacement and repair of a city watermain, together with service lines, meters and attendant facilities, over, under, across and through the following tract of land situated in Salt Lake County, Utah, the centerline of which begins at a point S.0°00'15" E. 5.833 feet and N.8°5'93" E. 5.833 feet from the N.W. cor. of Lot 12, Block 2, 5-Acre Plat "B", Big Field Survey, and running thence S.0°00'15" E. 446.209 feet.

SECTION 2. This ordinance shall take effect 30 days after its first publication.
