A right of way 10 feet in width, being 5 feet on each side of the following described survey line:

Beginning on the west boundary line of the Grantor's land at a point 1205 feet south and 33 feet east, more or less, from the northwest corner of Section 27, T.2 S., R.1 E., S.L.M., thence East 25 feet on said land and being in the NW1/4 of the NW1/4 of said Section 27.



Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the essement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches
