You have the right to request a hearing on this Notice of Violation within ten (10) days from the date it was issued. If the violation was mailed, the request must be made within fourteen (14) days. The request must be made in writing to the Nuisance Abatement Coordinator. Please include your name, address, telephone number, case number and violation address. A request will result in an administrative hearing which you should plan to attend. You may hire an attorney to represent you in the hearing although it is not required. An attorney will not be appointed for you. If you request a hearing and are found responsible for the violation(s) for which you were cited, you will be liable for ALL costs and expenses associated with the hearing including, but not limited to a \$100.00 Administrative Fee.

FAILURE TO PROPERLY FILE A WRITTEN REQUEST FOR A HEARING WITHIN TEN (10) DAYS WAIVES YOUR RIGHT TO A HEARING

CONSEQUENCES OF FAILURE TO CORRECT VIOLATIONS:

There are numerous enforcement options that can be used to encourage the correction of violations. These options include, but are not limited to: criminal prosecution; civil fees; revocation of permits; recordation of notice of violation; withholding of municipal permits; abatement of the violation; costs; administrative fees; tax liens against the property and any other legal remedies. The failure to pay fines assessed by the Notice of Violation may result in a claim with the Small Claims Court or any other legal remedy to collect such money. The City has the authority to collect all costs associated with the filing of such actions including administrative fees and service costs.
