

1957 W. Grantor and Vera B. Pettit, husband and wife, of the State of Utah, hereinafter referred to as Grantor, hereby convey to the UNITED STATES OF AMERICA, acting pursuant to the provisions of the Act of June 17, 1902 (32 Stat., 328) and acts amendatory thereof or supplementary thereto, Grantee, for the sum of One Dollar (\$1.00), a perpetual easement to construct, re-construct, operate and maintain an underground pipeline or pipelines and appurtenant structures which latter may protrude above the ground on, over or across the following described property in Weber County, State of Utah:

A strip of land in the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section Fifteen (15), Township Five (5) North Range One (1) West, Salt Lake Base and Meridian, Thirty (30.0) feet wide and included between two lines extended to the property lines and everywhere distant Fifteen (15) feet on the right or Northerly side and Fifteen (15) feet on the left or Southerly side of that portion of the following described centerline of what is known as the Uintah Bench Lateral 33N from Station 11+41.7 to Station 17+17.1 measured at right angles thereto; said centerline is more particularly described as follows:

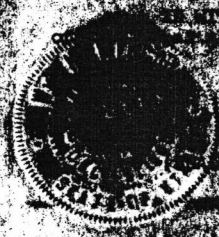
Beginning at Station 11+41.7, a point on the East line of the Grantor's property from which point the Southwest corner of said Section 15 bears South 63°46' West Twenty-eight Hundred Sixty and Eight-tenths (2860.8) feet, and running thence North 89°39' West Five Hundred Seventy-five and Four-tenths (575.4) feet to Station 17+17.1, a point on the West line of the Grantor's property, also being a point on the East line of State Road U-103, from which point the Southwest corner of said Section 15 bears South 57°30' West Twenty-three Hundred Sixty and Four-tenths (2360.4) feet, containing 0.40 of an acre more or less.
