DEED OF EASEMENT

DANIEL J. HAWKS and MARJORIE R. HAWKS, his wife, of Ogden, County of Weber, State of Utah, Grantors, hereby CONVEY to WEBER BASIN WATER CONSERVANCY DISTRICT, a water conservancy district of the State of Utah, of Layton, County of Davis, State of Utah, Grantee, for the sum of FIVE HUNDRED AND NO/100 (\$500.00) DOLLARS, and other valuable consideration, the following described easement located in Weber County, State of Utah:

A perpetual easement to construct, reconstruct, operate and maintain an underground pipeline and appurtenant structures, which latter may protrude above the ground surface, together with a road for operation and maintenance of said pipeline, on, over or across the following described property:

A tract of land in the Southeast Quarter of the Southwest Quarter of Section 15, Township 5 North, Range 1 West, Salt Lake Base and Meridian, being more particularly described as follows:

Beginning at a point on the centerline of what is known as the Weber Aqueduct at Station 194+31.0, a point on the East line of the Vendors' property, from which point the Southeast corner of said Section 15 bears South 65°36' East 2889.3 feet, and running thence South along the East line of the Vendors' property 163.5 feet; thence North 17°48' West 314.0 feet to a point on the North line of the Vendors' property; thence East along the North line of the Vendors' property 52.5 feet to Station 195+73.3, a point on the centerline of said Weber Aqueduct, from which point the Southeast corner of said Section 15 bears South 63°35' East 2986.4 feet; thence continuing East 43.5 feet to the Northeast corner of the Vendors' property; thence South along the East line of the Vendors' property 135.5 feet to the point of beginning.
