DEED OF EASEMENT

WHEREAS, Weber Basin Water Conservancy District, a conservancy District of the State of Utah, desires to obtain an easement to lay, construct, reconstruct, operate and maintain an underground water pipeline or pipelines and appurtenant structures, on, over and through certain lands in Weber County, Utah, as follows:

Section 15, Township 5 North, Range 1 West

which easement is more particularly hereinafter described, and

WHEREAS, Grantor s the owners _____ of certain lands in said Section

15, traversed by the said easement, and

_____ are willing to grant and convey the same to Weber Basin Water Conservancy District for the considerations hereinafter set forth.

NOW, THEREFORE, in consideration of the sum of \$ 150.00, to the

Grantor _____ paid by the Grantee, receipt of which is hereby acknowledged

Daniel J. Hawks and Marjorie R. Hawks Grantors _____

of Weber County, Utah, hereby grant s and convey s to Weber Basin

Water Conservancy District, its successors and assigns, the temporary and perpetual easements hereinafter described, on, over, across and through those portions of grantor's land lying in Section 15, traversed thereby:

A pipeline easement 16 feet wide parallel to and Westerly of and adjacent to the existing Weber Aqueduct the centerline of which is more particularly described below:

Beginning at a point on the East line of grantors property, from which point the SE cor. of Sec 15, T5N, R1W bears S 65°36' E 2889.3 ft, and running thence N. 17°48' W 142.3 ft to a point on the N line of grantor's property from which point the SE corner of said Sec 15 bears S 63°35' E 2986.4 ft.

Part 1 1555 to 1559 SD

Grantor s shall, subject to Grantee's rights as herein granted, have the right fully to enjoy and use the premises burdened by said easements, but grantors , their successors or assigns, shall not erect any permanent buildings or structures upon the lands comprising the perpetual easement without grantee's consent in writing.
