Said Grantor to fully use and enjoy said premises except for the purposes hereinabove granted.

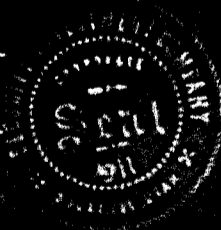
The rights herein granted, or any of them, may be exercised by any or all of the grantees herein, either jointly or separately.
