A Perpetual Easement on the following described tract of land for a traffic safety improvement known as Project No. SP-9999(325), Reference Project No. SP-1340, being part of an entire tract of property, situate in the SE ¼ of the SE ¼ of Section 3, Township 7 South, Range 2 East, Salt Lake Base and Meridian. The boundaries of said easement are described as follows:

Commencing at a point S00°30'29"E 530.36 m and S90°00'00"W 18.25 m from the West Quarter Corner of Section 2, Township 7 South, Range 2 East, Salt Lake Base and Meridian, said point being the intersection of the Northerly Highway Right of Way Line of State Road 114 and Easterly Highway Right of Way Line of State Road 114; thence N00°04'00"W 8.00 m along the Easterly Highway Right of Way Line of State Road 114; thence S45°02'00"E 11.32 m; thence S90°00'00"W 8.00 m along the Northerly Highway Right of Way Line of State Road 114 to the point of beginning. Area contains 32.0 square meters.
