facilities (hereinafter collectively called "facilities") through and across the following described land
and premises situated in the County of Weber , State of Utah , to-wit:

Land of the Grantors located in the Southwest Quarter of Section 5, Township 5 North, Range 1 West, Salt Lake Base and Meridian; Burch addition in South Ogden City;

the center line of said right of way and easement shall extend through and across the above described land and premises as follows, to-wit:

Beginning at a point located North 0° 58' West 55.0 feet from the Southwest Corner of Lot 5, Block 2, Burch addition, South Ogden City, in said Section 5, and running thence South 83° 42' 30" East 150.0 feet more of less to West property line of Wall Avenue.

TO HAVE AND TO HOLD the same unto the said Mountain Fuel Supply Company, its successors and assigns, so long as such facilities shall be maintained, with the right of ingress and egress to and from said right of way to maintain, operate, repair, inspect, protect, remove and replace the same. During temporary periods Grantee may use such portion of the property along and adjacent to said right of way as may be reasonably necessary in connection with construction, maintenance, repair, removal or replacement of the facilities. The said Grantors... shall have the right to use the said grantees except for the purposes for which this right of way and easement is granted to the said Grantee, provided such use does not interfere with the facilities or any other rights granted to the Grantee becauseder.

The Grantors... shall not build or construct nor permit to be built or constructed any building or other improvement over or across said right of way, nor change the contour thereof without written consent of Grantee. This right of way grant shall be binding upon and inure to the benefit of the successors and assigns of Grantor.s... and the successors and assigns of the Grantee, and may be assigned in whole or in part by Grantee.
