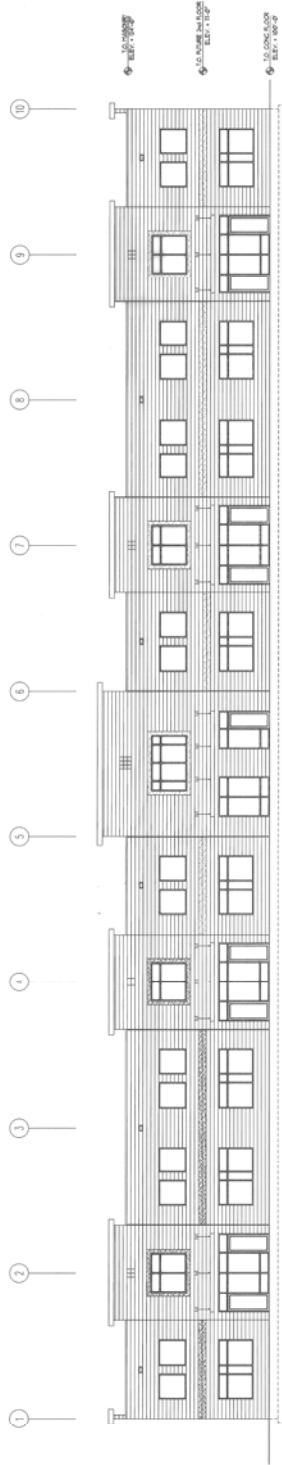


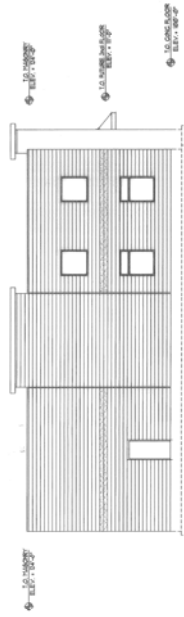


**SHEET 3 - SIDE VIEW - BLDG. ELEVATIONS**

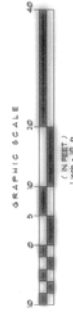

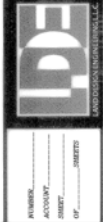


First Floor Plan
