EASEMENT

Price Oden Company a ~~corporation~~ Utah partnership doing business in the State of Utah, Grantor, hereby conveys and warrants to **UTAH POWER & LIGHT COMPANY**, a corporation, its successors and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the construction, operation and continued maintenance, repair, alteration, inspection, relocation and replacement of the underground electric transmission and distribution circuits of the Grantee, with the necessary transformers, transformer pads, pull boxes, service pedestals and other facilities related thereto, on, over, under and across a tract of land located in **Meber** County, Utah, along the following described center line:

Beginning on the east boundary line of the Grantor's land at a point 1350 feet south and 820 feet east, more or less, from the north one quarter corner of Section 20, T. 6 N., R. 1 W., S.L.M., thence S. 86° 47' W. 85 feet, more or less, to a new transformer pad on said land and being in the SW 1/4 of the NE 1/4 of said Section 20.
