RIGHT-OF-WAY AND EASEMENT GRANT

Land of the Grantor located in the Northwest Quarter of Section 8, Township 5 North, Range 1 West, Salt Lake Base and Meridian;

the centerline of said right-of-way and easement shall extend through and across the above-described land and premises as follows, to-wit:

Beginning at a point West 316.944 feet and South 497.509 feet from the Northeast Corner of the Northwest Quarter of said Section 8, and running thence South 38°20'59" West 352.979 feet.
