Thirty & no/100 Dollars, in consideration of which we hereby grant unto said Company, its successors and assigns, the right, privilege and authority to construct, operate and maintain its lines of Telephone and Telegraph, including the three necessary poles, wires and fixtures upon, over and across the property which we own, or in which we have any interest, in the following: All of that part of lot 9 Block 7-5 acre Flat "A" Ogden City Survey; Lying South of the Oregon Short Line Railroad Right of way, County of Weber and State of Utah and upon and along the roads, streets or highways adjoining the said property, with the right to permit the attachment of the wires of any other company, and the right to trim any trees along said lines so as to keep the wires cleared at least thirty-six inches, to erect and set the two necessary ~~guy and brace poles and~~ anchors and to attach thereto the necessary guy wires.
