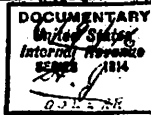

Warranty Deed.

Waldemar Van Cott and Ella C. Van Cott, his wife, Grantors, of Salt Lake City, Salt Lake County, Utah, hereby convey and warrant to Govey Investment Company, a corporation of Utah, Grantee, for the sum of Ten Dollars, the following described tract of land in Salt Lake County, Utah:

Commencing 1.3 feet west from the northeast corner of Lot 3, Block 14, Plat 10, Salt Lake City Survey, and running thence west 56.45 feet, thence south 165 feet, thence east 56.45 feet, thence north 165 feet to the place of beginning;

Together with a perpetual right of way over a tract of land adjoining the above described tract of land on the west and particularly described as follows: Beginning 3 1/2 rods west of the northeast corner of said Lot 3, and running thence west 4 feet, thence south 10 rods, thence east 4 feet, thence north 10 rods to the place of beginning;

And a strip of land 4 feet wide off of the west side of the tract first hereinabove described is subject to a right of way to be used in connection with the 4-foot right of way herein conveyed to the Grantee herein, making a right of way 8 feet wide by 10 rods deep for the use of the above named grantee and the owners of the tract of land adjoining said right of way on the west.
