PUBLIC UTILITY EASEMENT
(10' FRONT AND 7' SOUTH AND REAR)

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned Grantor, Land Rover of Centerville LLC, aka Auto Facilities of Centerville, LLC, hereby grants, conveys, sells and sets over unto Centerville City, a municipal corporation of the State of Utah, as Grantee, its successors and assigns, a perpetual right-of-way and easement to lay, maintain, operate, repair, inspect, protect, install, remove and replace public utilities and related structures and facilities, hereinafter called the "Facilities." Said right-of-way and easement being situated in Davis County, State of Utah, over and through a parcel of Grantor's land, which right-of-way and easement is more particularly described as follows:

Beginning at a point; said point lies N 89°45'08" E, a distance of 687.28'; thence N 00°08'03" E, a distance of 35.40' from the SW corner of Section 7, T2N, R1E, SLB&M and running thence S 89°45'08" W, a distance of 342.20' to the easterly line of the Utah State Highway Department Frontage Road; thence N 02°55'53" E, a distance of 391.67'; thence S 89°01'34" E, a distance of 10.01'; thence S 02°55'53" W, a distance of 384.45'; thence N 89°45'08" E, a distance of 324.84'; thence N 00°08'03" E, a distance of 90.00'; thence N 89°45'08" E, a distance of 143.77' thence N 00°08'03" E, a distance of 284.27'; thence S 89°01'34" E, a distance of 7.00'; thence S 00°08'03" W, a distance of 291.12'; thence S 89°45'08" W, a distance of 143.77'; thence S 00°08'03" W, a distance of 90.00'; which is the point of beginning, having an area of 9865.50 sq. feet, containing 0.226 acres.

TO HAVE AND TO HOLD the same unto said Grantee, its successors and assigns perpetually with right of ingress and egress in said Grantee, its officers, employees, agents, contractors and assigns to enter upon the above described property with such equipment as is necessary to install, maintain, operate, repair, inspect, protect, remove and replace said Facilities. During construction and/or maintenance periods, Grantee and its contractors may use such portions of the Grantor's property as may be reasonably necessary in connection with the construction, flushing or maintenance of the Facilities. The contractor performing the work shall restore all property, through which the work traverses, to as near its original condition as is reasonably possible. Grantor shall have the right to use said premises except for the purpose for which this right-of-way and easement is granted to the Grantee, provided

such use shall not interfere with the Facilities, or with Grantee's use thereof, or any other rights provided to the Grantee hereunder.

Grantor shall not build or construct, or permit to be built or constructed, any building or other improvement over or across said right-of-way, nor change the contour thereof, without the written consent of Grantee. This right-of-way and easement grant shall be binding upon and inure to the benefits of heirs, representatives, successors and assigns of the Grantor and the successors and assigns of the Grantee, and may be assigned in whole or in part by Grantee.

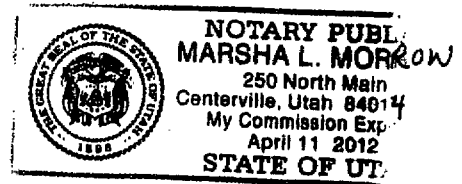
