**SECOND SUPPLEMENTAL DECLARATION RELEASING AND WITHDRAWING
PROPERTY FROM THE MASTER DECLARATION OF COVENANTS, CONDITIONS,
AND RESTRICTIONS AND RESERVATION OF EASEMENTS FOR
SUMMIT RIDGE COMMUNITIES**

AND

**AMENDMENT NO. 3 TO THE MASTER DECLARATION OF COVENANTS,
CONDITIONS, AND RESTRICTIONS AND RESERVATION OF EASEMENTS FOR
SUMMIT RIDGE COMMUNITIES**

A PLANNED COMMUNITY DEVELOPMENT IN SANTAQUIN, UTAH

THIS SECOND SUPPLEMENTAL DECLARATION RELEASING AND WITHDRAWING PROPERTY FROM THE MASTER DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS AND RESERVATION OF EASEMENTS FOR SUMMIT RIDGE COMMUNITIES AND AMENDMENT NO. 3 TO THE MASTER DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS AND RESERVATION OF EASEMENTS FOR SUMMIT RIDGE COMMUNITIES (the "**Supplement**") is executed this 27 day of August, 2021, by the Summit Ridge Owners Association, Inc., a Utah nonprofit corporation (the "**Association**") and HG Utah I, L.L.C., an Arizona limited liability company (the "**Declarant**").

RECITALS

A. A Master Declaration of Covenants, Conditions, and Restrictions and Reservation of Easements for Summit Ridge, A Planned Community Development in Utah and Juab Counties, Utah dated December 6, 2000 and recorded on September 17, 2001 as Entry Number 94243:2001 in the official records of Utah County, Utah (the "**Enabling Declaration**"), which was amended and replaced by that certain Master Declaration of Covenants, Conditions, and Restrictions and Reservation of Easements for Summit Ridge Communities, a Planned Community Development

in Santaquin, dated as of September 1, 2006 and recorded on September 1, 2006 as Entry Number 115136:206 in the official records of Utah County (the “**Amended and Restated Declaration**”), which superseded all prior versions of the Enabling Declaration and the Declaration of Covenants, Conditions, and Restrictions and Reservation of Easements dated as of April 7, 2000. The Amended and Restated Declaration was modified and/or supplemented by that certain First Amendment to Master Declaration of Covenants, Conditions, and Restrictions and Reservation of Easements for Summit Ridge Communities dated as of August 14, 2019 and recorded on August 14, 2019 as Entry Number 77782:20019 in the official records of Utah County and recorded in the official records of Juab County (collectively, the “**Declaration**”).

B. The Declaration was recorded against the real property located in Utah and Juab Counties, State of Utah (the “**Entire Property**”).

C. The Entire Property includes certain real property that is intended to be developed as residential property for detached and attached single family homes, which is described in Exhibit B, attached hereto (the “**Residential Property**”) and commercial property for retail, office, and commercial purposes (the “**Commercial Property**”).

D. The Commercial Property is composed of five (5) parcels. Four parcels comprising the Commercial Property (namely, Parcels 1, 2, 3A and 3B) were withdrawn from the Project and the remaining parcel comprising the Commercial Property (Parcel 4) will be withdrawn from the Project upon the conveyance of that Parcel pursuant to the terms and conditions of a Supplemental Declaration Releasing and Withdrawing Property from The Master Declaration of Covenants, Conditions, and Restrictions and Reservation of Easements For Summit Ridge Communities and Amendment No. 2 to The Master Declaration of Covenants, Conditions, and Restrictions and Reservation of Easements for Summit Ridge Communities dated as of February 5, 2021 and recorded on February 8, 2021 in the official records of Juab County as Entry Number 00298710 in Book 0605 at Page 1623, and a Supplemental Declaration Releasing and Withdrawing Property from The Master Declaration of Covenants, Conditions, And Restrictions and Reservation of Easements for Summit Ridge Communities and Amendment No. 2 To The Master Declaration of Covenants, Conditions, and Restrictions and Reservation of Easements for Summit Ridge Communities dated as of February 5, 2021 and recorded on February 8, 2021 in the official records of Utah County as Entry Number 23190:2021.

E. The Entire Property, less Parcels 1, 2, 3A and 3B of the Commercial Property that have previously been withdrawn, is more particularly described in Exhibit A, attached hereto and incorporated herein.

F. The Declarant and the Association acknowledge that pursuant to Section 11.8(a) of the Declaration, Declarant has the unilateral right to amend the CC&Rs at any time until 95% of the developable acreage of the Entire Property as set forth in the Summit Ridge Development Plan is sold and that consent of the members of the Summit Ridge Owners Association, Inc. is not required until the 95% ownership threshold is satisfied.

G. The Declarant continues to own in excess of five percent (5%) of the developable acreage of the Entire Property.

H. The Declarant Control Period is still in effect.

I. The Declarant desires to withdraw the real property described in Exhibit B, attached hereto and incorporated herein (the “**Withdrawn Property**”) from the governance of the Declaration.

NOW, THEREFORE, in consideration of the above recitals, which are incorporated herein and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, Declarant hereby withdraws the Withdrawn Property from the governance of the Declaration pursuant to the terms and conditions set forth herein:

1. **Withdrawal of Withdrawn Property.** Upon the recordation of this instrument, Declarant hereby removes and withdraws the Withdrawn Property from the property encumbered and governed by the Declaration. Upon the withdrawal of the Withdrawn Property, the Declaration and the covenants, conditions, restrictions and obligations set forth in the Declaration shall no longer apply to the Withdrawn Property, and the Declaration is fully and completely released as it pertains to the Withdrawn Property whereby the Declaration is of no further force or effect as to the Withdrawn Property. Upon the withdrawal of the Withdrawn Property, the Association and any Owner and anyone claiming, by, through or under them, including any members of the Association, release, remise, vacate, abandon, and terminate any and all covenants, conditions, restrictions, and interests in and to the Withdrawn Property. By signing below, the Association acknowledges and agrees to the withdrawal of the Withdrawn Property from the property encumbered and governed by the Declaration. As a result of the withdrawal of the Withdrawn Property from the governance of the Declaration, the Declaration shall solely encumber and pertain to the remainder of the property thereunder.

2. **Miscellaneous.** The recitals are hereby incorporated into this Supplement. Any defined terms used herein that are not defined herein shall have the definitions ascribed to them in the Declaration. Except as provided herein, the terms and conditions of the Declaration shall remain the same and in full force and effect and are incorporated herein as amended hereby.

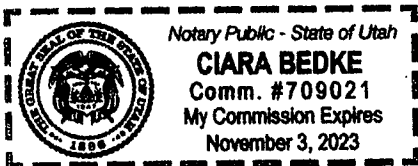

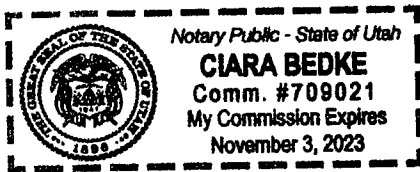
