Atkin grantors of Tooele, County of Tooele, State of Utah, hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the of Forty three and 35/100 ----- DOLLARS, the following described strip or parcel of land, as a perpetual right of way for highway purposes across the grantors land in Tooele County, State of Utah, as follows:

Right of way for highway known as DA-WR Project No. 15 across the grantors land in the SE 1/4 of Section 32 and the NW 1/4 SW 1/4 of Section 33, T. 3 S., R. 4W., S.L.M. Caldwell, a widow grantor of Tooele, County of Tooele State of Utah, hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of Fifteen ----DOLLARS, the following described right of way across the grantor land in Tooele County, State of Utah, as follows:

Right of way for highway known as DA-WR Project No. 15 across the grantors land in the E $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 32 and the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 33, T. 3 S., R. 4 W., S.L.M. Said right of way is contained within a parcel of land 50 ft. wide, 50 ft. on the northwesterly side of the center line of survey of said project. Said center line is described as follows:
