MARRIOTT-SLATERVILLE CITY ORDINANCE 2015-02

COMMUNITY DEVELOPMENT AND RENEWAL AGENCY

AN ORDINANCE OF MARRIOTT-SLATERVILLE CITY, UTAH, ADOPTING CHAPTER 2.18 OF THE MUNICIPAL CODE TO PROVIDE FOR COMMUNITY DEVELOPMENT AND RENEW AS SET FORTH IN STATE LAW; SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Marriott-Slaterville City (hereafter "City") is a municipal corporation, duly organized and existing under the laws of the State of Utah;

WHEREAS, Utah Code Annotated §§ 10-8-84 and 10-8-60 allow municipalities in the State of Utah to exercise certain police powers and nuisance abatement powers, including but not limited to providing for safety and preservation of health, promotion of prosperity, improve community well-being, peace and good order for the inhabitants of the City;

WHEREAS, Title 17C of the *Utah Code Annotated*, 1953, as amended, provides for the "Limited Purpose Local Government Entities – Community Development and Renewal Agencies Act";

WHEREAS, the City Council to create entities authorized in the Limited Purpose Local Government Entities – Community Development and Renewal Agencies Act;

NOW, THEREFORE, be it ordained by the City Council of Marriott-Slaterville as follows:

Section 1: Repealer. Any ordinance or portion of the municipal code inconsistent with this Ordinance is hereby repealed and any reference thereto is hereby vacated.

Section 2: Adoption. Chapter 2.18 of the *Marriott-Slaterville Municipal Code* is hereby adopted to read as follows:

Chapter 2.18 Community Development and Renewal Agency

Sections:

2.18.010. Establishment.

2.18.020. Agency Board and Executive Director.

2.18.030. Powers.2.18.040. Boundaries.

2.18.010. Establishment.

In accordance with Title 17C of the *Utah Code*, the Marriott-Slaterville City Council hereby establishes and designates the Marriott-Slaterville City Community Development and Renewal Agency for the purpose of implementing the Utah "Limited Purpose Local Government Entities – Community Development and Renewal Agencies Act" as amended.

2.18.020. Agency Board and Executive Director.

The Marriott-Slaterville City Council shall constitute the governing board of the Marriott-Slaterville Community Development and Renewal Agency. In accordance with *Utah Code Annotated* 17C-1-203 (4), the mayor shall serve as the executive director of the Marriott-Slaterville Community Development and Renewal Agency and execute the executive powers of the same.

2.18.030. Powers.

The Marriott-Slaterville Community Development and Renewal Agency shall exercise all the powers set forth in Utah Code Annotated §17C-1-202, 1953, as amended, and another applicable law.

2.18.040. Boundaries.

In accordance with *Utah Code Annotated* §17C-1-201, the boundaries of the Marriott-Slaterville Community Development and Renewal Agency shall always be coterminous with the boundaries of Marriott-Slaterville City.

Section 3: Severability. If a court of competent jurisdiction determines that any part of this ordinance is unconstitutional or invalid, then such portion of the ordinance, or specific application of the ordinance, shall be severed from the remainder, which shall continue

in full force and effect.

Section 4: Effective date. This Ordinance take effect immediately upon mayoral approval and posting.



Thence South 89°03'15" East along the approximate centerline of 1200 South street 1460 feet, more or less, to a point which intersects the East line of the Northwest Quarter of Section 19,

Thence South 00°45'56" West along the Quarter Section line (also being the Ogden City boundary line) 3717 feet, more or less, to the South Quarter corner of Section 19 and the West Haven City boundary line,

Thence South 89°38'00" West along the South line of the Southwest Quarter of Section 19 (also being the West Haven City boundary line 1350 feet, more or less, to a point which intersects the "main channel" of the Weber River,

Thence meandering Northwesterly along the "main channel" of the Weber River (also being the West Haven City boundary line) through Sections 19, 24, and 23, to a point which falls North 835 feet, more or less, and West 660 feet, more or less, from the Southeast corner of the Northwest Quarter of Section 23,
