The South West quarter of the South East quarter Section twenty six (26) Township five (5) South, Range One (1) East, Salt Lake Base & Meridian.

R I G H T O F W A Y E A S E M E N T

William A. McKenzie and Grace E. McKenzie, his wife, of Utah County, State of Utah, Grantor, for One Dollar and other valuable considerations paid by Utah Power Company, a Maine Corporation, Grantee, receipt of which is hereby acknowledged, hereby grant, bargains, sell and convey to said Utah Power Company, its successors and assigns, an easement and right of way, and the the right, privilege and authority to construct, erect, operate and maintain, a line or lines. for the purpose of transmitting electric or other power, and telegraph and telephone lines, in, upon, along, over, through, across and under a piece of land 50 feet in width, situated in the County of Utah and State of Utah, and more particularly described as follows, to-wit:

Twenty five feet on each side of a line as may be constructed approximately along and over the following described course:

Commencing on North boundary of Grantor's land 1640 feet South of a point 1682 feet East of the N. W. corner Section 34, Township 7 South, Range 3 East, Salt Lake Meridian; thence S. 9° 03' E. 300 feet more or less to South boundary of Grantors's land, All contained within the N. W. 1/4 Sec, 34, Tp. 7. S. R. 3 E. S. L. M. Including no towers or poles.

In the event that the Grantee, its successors or assigns, shall at any time determine to build a second transmission line, parallel and adjacent to the line or lines to be constructed upon the said 50 foot strip hereinbefore described, then and in that event
