WOODRUFF C. THOMSON and IRENE G. THOMSON, his wife, do hereby convey to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of ONE DOLLAR (\$1.00), and other valuable consideration, a perpetual easement and right-of-way, along with necessary right of ingress and egress, for the erection, operation, and continued maintenance, repair, alteration, inspection, relocation and replacement of one or more transmission circuits and distribution circuits of the Grantee, with the necessary poles, towers, guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said circuits, on, over, and across the following described real property located in Utah County, to-wit:

Said tract of land situate in the NW 1/4 of the SE 1/4 of Section 26, Township 5 S., Range 1 E., SLM., described as follows:

Beginning at the west boundary line of the Grantors' land at a point 1600 feet north and 305 feet east, more or less, from the south one quarter corner of Section 26, T. 5S., R. 1 E., S.L.M., and running thence North 137 feet, more or less, along said west boundary line, thence S. 65°07' E. 300 feet, more or less, to the east boundary line of said Grantors' land, thence South 137 feet, more or less, along said east boundary line, thence N. 65°07' W. 300 feet, more or less, to the point of beginning.

Containing 0.86 of an acre, more or less.

Together with all right and authority to Grantee, its successors, licensees, lessees, contractors or assigns, and its and their agents and employees to enter at all times upon said premises to survey, construct, repair, remove, replace, reconstruct, patrol, inspect, improve, enlarge and maintain electric transmission and distribution lines and communication facilities, both overhead and underground, including towers, poles, and other supports, together with braces, guys, anchors, crossarms, cables, conduits, wires, conductors, manholes, transformers and other fixtures, devices, and appurtenances used or useful in connection therewith, and full right and authority to cut, remove, trim, or otherwise control all trees, brush and other growth on or overhanging said premises.

At no time shall any fires be permitted within the boundaries of said right-of-way, nor shall any residential or commercial structures or inhabitable or inhabited trailers be placed or erected within the boundaries of said right-of-way, nor shall any flammable material (including, but not limited to, explosives, chemical solvents, gasoline, rubbish piles, haystacks, or lumber products) be placed or stored within the boundaries of said right-of-way, nor shall any building, structure, equipment, or material in excess of 12 feet in height be placed, stored, or erected within the boundaries of said right-of-way by Grantors, or by Grantors' heirs, agents, contractors, successor in interest or assigns.
