Box 11248, Salt Lake City Utah, 84147, (herein "GRANTEE") all of that certain property situated in Salt Lake and Tooele Counties, State of Utah, more particularly described in Exhibit "A" attached hereto and by this reference made a part hereof and all waters, minerals, oil, gas, rights-of-way, easements, leases, rents, issues, profits, income, tenements, hereditaments, privileges and appurtenances thereunto belonging, now or hereafter used or enjoyed therewith or any part thereof.
