RIGHT OF WAY AGREEMENT FOR
SALT LAKE CITY SUBURBAN SANITARY DISTRICT PIPE LINE

of Salt Lake County, State of Utah, Grantors, do hereby convey and warrant to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing under and by virtue of the laws of the State of Utah, Grantee, for the sum of ~~One Dollar and~~ other consideration

~~ONE DOLLAR~~ (\$ 1.00) receipt of which is hereby acknowledged, a right of way and easement for the purpose of digging a trench along said right of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through and across the Grantors land and premises in Salt Lake County, State of Utah, and located in: Com 2 rds W & 25.3 rds N fr S E Cor of Lot 9, Blk 3, Ten Acre Plat "B", Big Field Survey. N 89°51' W 110 ft; S 0°22' E 300 ft; S 89°51' E 110 ft; N 0°22' E 300 ft to beg. 0.76 Ac.

the center line of said pipe shall extend through and across the above land and premises on a line described approximately as follows:

Enters East property line at a pt 168 ft South fr the N E Cor of above described property, thence West 110 ft M or L to the West property line, at a pt 160 ft South fr the N W Cor of said property.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so long as such pipe line shall be maintained, with the right of ingress and egress to and from said right of way, and to maintain, operate, repair, remove or replace the same. The said Grantor... to fully use the said premises except for the purposes for which this right of way or easement is granted to the said Grantee.

The rights hereby granted are subject to the condition that Grantee shall compensate Grantor at a reasonable appraised valuation for any damages done to Grantor's land or crops caused by Grantee in the construction, maintenance, repair and operation or replacement of said pipe line.

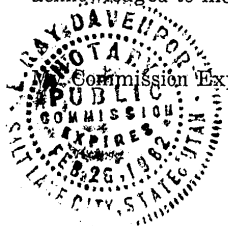
