MODIFICATION OF DEED OF TRUST

THIS MODIFICATION OF DEED OF TRUST dated January 23, 2019, is made and executed between TERRA BASIN, LLC, whose address is 475 NORTH 300 WEST #204, KAYSVILLE, UT 84037 ("Trustor") and Goldenwest Federal Credit Union, whose address is 5025 South Adams Ave, Ogden, UT 84403 ("Lender").

DEED OF TRUST. Lender and Trustor have entered into a Deed of Trust dated January 23, 2019 (the "Deed of Trust") which has been recorded in UTAH County, State of Utah, as follows:

CONSTRUCTION DEED OF TRUST DATED NOVEMBER 8, 2017 AND RECORDED AS ENTRY NO. 111660 IN THE OFFICE OF THE UTAH COUNTY RECORDER.

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in UTAH County, State of Utah:

Lots 4 & 5, Springville Market Place, a Commercial Subdivision, according to the official plat thereof on file and of record in the office of the Utah County Recorder.

The Real Property or its address is commonly known as 1101 WEST 400 SOUTH and 977 WEST 400 SOUTH, SPRINGVILLE, UT 84663. The Real Property tax identification number is 66-527-0004, 66-527-0005.

MODIFICATION. Lender and Trustor hereby modify the Deed of Trust as follows:

CHANGE FROM A CONSTRUCTION LOAN TO A LONG TERM; CHANGE FROM MONTHLY INTEREST ONLY PAYMENTS TO MONTHLY PRINCIPAL AND INTEREST PAYMENTS; CHANGE INTEREST RATE FROM A VARIABLE RATE OF PRIME PLUS 1.25% TO A FIXED RATE OF 5.25%; PRINCIPAL BALANCE INCREASED TO \$3,686,246.00.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons

signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. 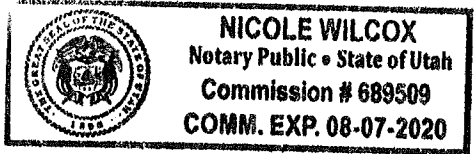

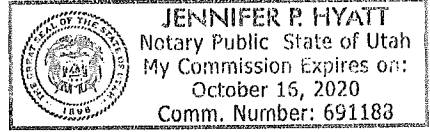
