THIS DEED, Made the 24th day of April A.D. 1947 between NEWEL S. BROWN as Bishop of the Wilson Ward of the Church of Jesus Christ of Latter-day Saints, in the County of Salt Lake, State of Utah, residing at Salt Lake City, in said County and State, party of the first part, and the WILSON CORPORATION OF THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS, a corporation sole, created and existing under and by virtue of the laws of the State of Utah, party of the second part, WITNESSETH:

THAT WHEREAS, the legal title to the land and premises hereinafter described was vested in the party of the first part, as Bishop of the Wilson Ward of the Church of Jesus Christ of Latter-day Saints in the County of Salt Lake, State of Utah, and thereafter, said party of the first part, as such Bishop, incorporated under the laws of the State of Utah, in such case made and provided, and became a corporation sole under the name of the WILSON CORPORATION OF THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS; and

WHEREAS, the said party of the second part is the owner of said premises, and it is desired to vest the title thereto in said corporation;

NOW, THEREFORE, the party of the first part, for and in consideration of the sum of One (\$1.00) Dollar, to him in hand paid by the party of the second part, the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell and convey unto the said party of the second part, its successors and assigns forever, all of the following described land and premises, situated in the County of Salt Lake, State of Utah, to-wit:

Commencing at a point 187 feet West of the Northeast corner of Lot 16, Block 5, Five Acre Plat "A", Big Field Survey and running thence West 268.4 feet; thence South 7-17/69 rods; thence East 268.4 feet; thence North 7-17/69 rods to the place of beginning.

TOGETHER with all and singular the tenements, hereditaments, and appurtenances thereunto belonging or in anywise appertaining.

TO HAVE AND TO HOLD all and singular the said premises, with the appurtenances, unto the said party of the second part, and to its successors and assigns forever.
