QUITCLAIM DEED

(Underground Tunnel System)

UNITED PARK CITY MINES COMPANY, a Delaware corporation, at the address of P.O. Box 1450, Park City, Utah 84060, GRANTOR, hereby quitclaims, grants, and conveys to JORDANELLE SPECIAL SERVICE DISTRICT, a special service district created by Wasatch County, State of Utah, at the address of P.O. Box 519, Heber City, Utah 84032, GRANTEE, for the sum of Ten Dollars (\$10.00) and other valuable consideration, GRANTOR's underground rights, title, and ownership interests in and to the Ontario No. 2 Drain Tunnel, the Ontario No. 3 Shaft, the Ontario No. 6 Shaft, and other associated tunnels, drifts, and shafts, and the Ontario No. 1 Drain Tunnel, located in Summit and Wasatch Counties, State of Utah (hereinafter collectively described as the "Underground Tunnel System"), with the following underground centerlines, through tunnels and drifts in the Underground Tunnel System to shafts in the Underground Tunnel System, being described in Exhibit "A" attached hereto and incorporated herein by reference:

- (1) Underground centerline from the portal of the Ontario No. 2 Drain Tunnel to the Ontario No. 3 Shaft; then to the Daly West Shaft; also, the underground centerline on the drift from the Ontario No. 2 Drain Tunnel to the Ontario No. 6 Shaft; and
- (2) The underground centerline from the portal of the Ontario No. 1 Drain Tunnel to the Ontario No. 3 Shaft and from the Ontario No. 3 Shaft to the Daly West Shaft;

EXCEPTING AND RESERVING UNTO THE GRANTOR, its successors and assigns, the mineral estate and all ores and minerals of whatever nature or character situated in, upon, above, around or under the Underground Tunnel System, including by way of example and without limitation, reservation of all liquid, solid, and gaseous hydrocarbons, oil and natural gas, helium, carbon dioxide, coal and lignite, gold, silver, lead, zinc, copper, uranium, iron, precious, semi-precious and non-precious stones and jewels, and metalliferous and nonmetalliferous minerals, whether or not now known to exist or to have value, of whatever form or type, at whatever depth, in whatever nature of deposit, whether solid, semi-solid, liquid, or gaseous, whether similar or dissimilar to any of those enumerated;

GRANTOR FURTHER EXPRESSLY EXCEPTS AND RESERVES to itself, its successors and assigns, a perpetual easement for GRANTOR's access to GRANTOR's mineral estate, by means of underground access, throughout the Underground Tunnel System, provided that GRANTOR's use of its perpetual easement will not materially impact nor interfere with GRANTEE's use or occupancy of its property or operations, nor adversely impact the quantity or quality of water flowing from the Ontario No. 2 Drain Tunnel or the federal and state-mandated effluent limitations on water flowing from the Ontario No. 2 Drain Tunnel. GRANTOR's perpetual easement throughout the Underground Tunnel System shall include the right to use the hoist in the Ontario No. 3 Shaft as a means of access through the Ontario No. 3 Shaft. Because of safety concerns, GRANTOR will inform GRANTEE prior to entering upon GRANTOR's easement throughout the Underground Tunnel System, and GRANTOR will provide GRANTEE with prior written notification before GRANTOR commences conducting any significant activity upon GRANTOR's easement.

GRANTOR FURTHER EXPRESSLY EXCEPTS AND RESERVES to itself, its successors and assigns, a perpetual easement within the Underground Tunnel System for the use, operation, maintenance, and repair of GRANTOR's sewer line from GRANTOR's various offices and operations down the Ontario No. 3 Shaft and through the Ontario No. 1 Drain Tunnel and across the portal of the Ontario No. 1 Drain Tunnel in order to connect GRANTOR's sewer line with the Snyderville Basin Water Reclamation District.

THIS QUITCLAIM DEED is specifically subject to any valid prescriptive easements acquired by third parties in and to any portion of the Underground Tunnel System, and this Quitclaim Deed is subject to any easements and rights of way in the Underground Tunnel System which have been granted by GRANTOR and its predecessor companies to third parties.

THIS QUITCLAIM DEED is also subject to the terms and provisions of that Agreement, dated May 3, 2002, as amended, by and between GRANTOR and GRANTEE, regarding the Underground Tunnel System.
