This is to certify that on this 11th day of January 2002, Ogden City acknowledges the nonconforming building and site 725 25th Street. This property is located in an R-3EC zone, and has a nonconforming right for a 6-plex.

The nonconforming building is limited to:

- A 8' side yard setback where a 10' setback is required.
 - A 13' rear yard setback where a 30' setback is required.
- 4,900.5 sq.ft. of lot area where 15,500 sq.ft. of lot area is required for a 6-plex.

The nonconforming site is limited to:

No legal parking spaces where 12 stalls are required.

THE RIGHT OF THE NONCONFORMING BUILDINGS SHALL BE LOST IF THE BUILDING IS REMOVED OR DEMOLISHED.

In the event that the structure is damaged or destroyed, it may be rebuilt, provided the restoration is started within a period of one year from the damage and is diligently pursued to completion, and the nonconformity is not increased.

This nonconforming building shall not be added to, nor enlarged in any manner, except by permit of the Ogden City Board of Zoning Adjustment.
