## **MEMORANDUM OF LEASE**

November 23, 2002

THIS MEMORANDUM OF LEASE ("Memorandum") is made and entered into effective as of the date first set forth above, by and between MIDDLEFORK MEADOWS, LLC, a Utah limited liability company ("Landlord"), and MANOS PLASTICS, LLC, a Utah limited liability company ("Tenant").

For and in consideration of Ten Dollars (\$10.00), the rents reserved and the terms and conditions more particularly set forth in that certain Lease Agreement and Addendum to Lease, each of which are dated on or about the date hereof and made by and between Landlord and Tenant (collectively, the "Lease"), and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Landlord leased to Tenant, and Tenant leased from Landlord, certain premises consisting of roughly 15,120 square feet of usable space, together with all improvements thereon and appurtenances thereto (the "Premises"), located within a roughly 23,000 square foot building (the "Building"), where such building is located on certain real property in Salt Lake County, Utah more particularly described on Exhibit "A" attached hereto and incorporated herein (the "Property").

The Lease includes, but are not limited to, the following terms and conditions:

- 1. The term of the Lease commenced on the date first set forth above and expires exactly five years after the first day of the calendar month commencing immediately after such commencement date. Tenant holds an option to extend the term of the Lease for one additional five (5) year period.
- 2. <u>Purchase Option</u>. During the initial five (5) year term of the Lease, Tenant, or any assignee entity owned or controlled by Tenant or Paul P. Manos, has the right and option to purchase the Property.
- 3. Right of First Refusal. In the event Landlord shall attempt to offer, negotiate or execute any agreement regarding the sale to a third-party of all or any portion of the Property during the initial five (5) year term of the Lease, Landlord shall first notify Tenant in writing of the proposed sale and all material terms of the proposed sale and offer to sell the Property to Tenant upon such terms and conditions. Tenant shall have a period of 60 days within which to accept Landlord's offer to sell the Property on terms and conditions at

least as favorable as those negotiated (or contemplated to be negotiated) with such third-party.

All terms and conditions of the Lease are incorporated herein by reference as though set forth fully. In the event of any conflict between the terms hereof and of the Lease, the Lease shall prevail.


