to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing
under and by virtue of the laws of the State of Utah, Grantee, for the sum of

One DOLLARS (\$ 1.00) receipt of which is hereby

acknowledged, a right of way and easement for the purpose of digging a trench along said right
of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through
and across the Grantors land and premises in Salt Lake County, State of Utah, and located in:
Beg at a point in center of Highland Dr, said point N 0°04'54" E along N-S 1/4 Sec. line
113.85', S 89°26'40" E along a line parallel with E-W 1/4 sec. line 450.58' to center
line of Highland Dr & N 14°04'30" W along centerline 148.1' from the center of Sec. 4
T2S, R1E, SL B & M; thence S 89°49' W 305.13'; th N 4°22' W 175.2'; th W 75.5'; th N 37°
08' W 21.76; th N 2°03' E 42.76; th W 91.61'; th S 35°28' W 52.24'; th S 81° W 18.68' to
an old fence line; th N 2°02'20" E along old fence line 86.76' to projection of fence
line; th along projection & existing fence line, S 89°31'40" E 269.04' & S 89°58'20" E
205.48' to centerline of Highland Dr; th S 14°04'30" E along centerline 280.82' to
point of beg.

the center line of said pipe shall extend through and across the above land and premises on a line
described approximately as follows:

All main line sewer extensions to serve two or more buildings. Width of easement
to be 5 feet each side of center line of pipe.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so
long as such pipe line shall be maintained, with the right of ingress and egress to and from said
right of way, and to maintain, operate, repair, remove or replace the same. The said Grantor...
to fully use the said premises except for the purposes for which this right of way or easement is
granted to the said Grantee.

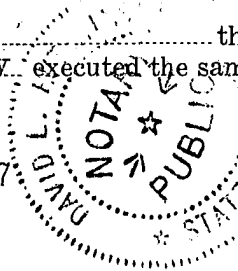
