AGREEMENT (GROUND)


THIS MEMORANDUM OF AMENDMENT TO COMMUNICATIONS SITE LEASE AGREEMENT (GROUND) ("Amended Memorandum"), by and between STEWART L. GROW, successor in interest to 4910 Associates L.L.C., a Utah limited liability company ("Lessor"), evidences that the lease made and entered into by written COMMUNICATIONS SITE LEASE AGREEMENT (GROUND) between Lessor and Lessee or Lessee's affiliate, dated August 3, 1998 as amended by Amendment No. 1 to Communications Site Lease Agreement (Ground) dated June 29, 2001, (collectively the "Agreement"), has been amended by written agreement between the parties (the "Amendment"). The parties caused to be recorded a Memorandum of Agreement with the Office of County Recorder, County of Salt Lake, State of Utah, as document number 7313497, Book 8265, Pages 8238-8241 on April 6, 1999.

The Amendment provides in part that Lessor leases to Lessee certain real property owned by Lessor and located at 4910 West Amelia Earhart Drive, City of Salt Lake City, County of Salt Lake, State of Utah, together with non-exclusive utility and access easements (the "Leased Premises"). The Land which is the subject of the Agreement is described in Exhibit A attached hereto. The Amendment grants Lessee the option to extend the Agreement for five (5) additional sixty (60) month terms after the expiration of the new initial sixty (60) month term which commenced on December 1, 2007.
