Together with the right of ingress and egress at all times for the purpose of mining, drilling and exploring said lands for oil, gas and other minerals and removing the same therefrom.

To have and to hold all and singular, the above described interest subject to all agreements, conditions, restrictions and reservations of record; this conveyance being made without warranty or other assurances, express or implied. Transferor further disclaims all personal or individual

liability or responsibility herein, with responsibility being only in the capacity as Trustee, as such, only to the extent of Trustee.

Subject to all taxes, assessments and liens thereon and to all legal encumbrances existing as of the date of this Deed.

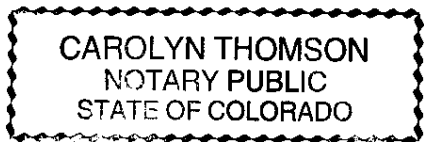
