Based on the Utah Coordinate System, Central Zone, established by the United States Coast and Geodetic Survey, the Northwest corner of said Section 26 has plane grid coordinates North 776,374.75 and East 2,546,200.79 and the Southwest corner of said Section 26 has plane grid coordinates North 771,056.11 and East 2,546,386.90. The coordinates of the Northwest corner of said Section 26 were computed by the double proportion method.

Ground distances in the foregoing description can be converted to U.S.C.& G.S. grid distances by multiplying by the combination factor of 0.9996879.

Subject to coal, oil, gas and mineral rights reserved to or outstanding in third parties as of February 17, 1971; also subject to rights-of-way for roads, railroads, telephone lines, transmission lines, ditches, conduits or pipelines, on, over or across said lands in existence on said date.
