DAGGETT COUNTY ORDINANCE NO: 97-11

AN ORDINANCE ESTABLISHING
DAGGETT COUNTY SERVICE AREA NO. 1

WHEREAS, the Daggett County Commission is authorized to adopt ordinances to create county service areas for unincorporated areas to enable those areas to receive special types of services not common to the entire county and establish a system for the payment of the costs entailed; and

WHEREAS, the Mountain View Subdivision has petitioned for a county service area for the purpose of road improvement.

NOW THEREFORE:

The County Legislative Body of the County of Daggett, State of Utah ordains as follows:

Section I. ESTABLISHMENT

The Daggett County Commission declares that Daggett County Service Area No. 1 is hereby established.

Section II. BOUNDARIES

The Daggett County Commission determines and establishes the boundaries of the Daggett County Service Area No. 1 to be as follows:

Beginning at the Southeast corner of Section 19, Township 3 North, Range 20 East, Salt Lake Base & Meridian and running thence; South 89°56'00" West 3969.08 feet, thence; North 0°26'12" East 1984.46 feet, thence; South 89°59'50" East 1321.99 feet, thence; North 0°24'25" East 660.95 feet, thence; South 89°58'26" East 2643.28 feet, thence; South 0°20'51" West 2639.50 feet to the point of beginning. Contains 220.60 acres more or less. 44 Lots.

Section III. TYPES OF SERVICE

The Daggett County Commission designates that the type of service to be provided is road improvement.

Section IV. METHOD OF PAYMENT

The services are to be paid for by an ad valorem property tax.

SECTION V. INITIAL BOARD OF TRUSTEES

The Daggett County Commission declares that the Daggett County Commission shall act as the trustees of the service area initially, subsequent trustees shall be appointed or elected in accordance with Utah Code Annotated Section 17A-2-411.

SECTION VI. EFFECTIVE DATE

The effective date of this ordinance shall be November 5, 1997.
