DEED

JOHN M. WALLACE and GLENN WALKER WALLACE, his wife, HAROLD H. BENNETT and EMILY BENNETT, his wife, L. B. SWANER and JUNE S. SWANER, his wife, and L. S. SWANER, a single person, residents of Salt Lake County, State of Utah, Grantors, hereby convey and warrant to SALT LAKE CITY, a municipal corporation of the State of Utah, Grantee, for the sum of One and no/100 Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged,

A perpetual easement over and across a parcel of land for the purpose of operating and maintaining thereon an existing open canal conveying storm drainage and surface runoff water, aid easement being 100 feet wide and extending 50 feet on each sine of the center lines described as follows:

regimming at a point 476.3 feet East of the projected centerline of capire wood and 97.1 feet forth of the projected centerline of 15th South Street, bearing thence S. 57° 50° %, 3171. 53 feet to a point of tangency wi a curve to the left having a radius of 75 feet, said point of tangency being 773.25° feet worth of the centerline on Swaner Road and 99.6 feet North of the projected centerline on 15th S with Street; thence southwesterly, 117.45 feet along the arc of said curve; thence S. 0° 13' W., 532.95 feet to a point of tangency with a curve to the right having a radius of 75 feet; thence southwesterly 117.45 feet along the arc of last said curve; thence S. 39° 55' %, 2079.41 feet to a point 202.85 feet south of the centerline along Andrew Ave., and 1275.15 feet along the centerline on Pioneer Road; thence S. 72° 20' %., 1435.55 feet along the centerline of an existing treated sewage effluent drain ditch known as the Lee Creek Drain Canal, thence S. 70° 28' W., 53 feet to a boundary fence; thence westerly along the centerline of said drain canal as constructed across Sections 16, 17 and 18 of Township 1 South, mannel 1 Mest, Salt Lake Ease and Meridian and Sections 13, 14, 15 and Section 10, of Township 1 South, Range 2 West, Salt Lake Base and Meridian, to the point of discharge into a natural channel known as Lee Creek.

Also beginning at a point which is 202.86 feet south of the centerline of Andrew Avenue and 1242.76 feet West of the centerline of Pioneer Road; bearing thence S. 0° 05' E., 2029.53 feet to a point of tangency with a curve to the left having a radius of 100 feet; thence southeasterly 157.14 feet along the arc of said curve; thence N. d9° 53' E., 670.54 feet.

Also, beginning at a point on the centerline of the main channel of said \sqrt{a} in Area Drainage Canal, which point is 486.5 feet West of the centerline of Pioneer Road and approximately 203 feet South of the centerline of Andrew Avenue; bearing thence S. 0° 07' E., 714.0 feet.

C. W. A. DRAIN DITCH NO. 3

A perpetual easement over and across a parcel of land contained within the S. E. 1/4 of Section 9, the S. w. 1/4 of Section 10 and the E. 1/2 of Section 16, Township 1 South, Range 1 West, S. L. . & M., for the purpose of operating and maintaining thereon an existing open drainage ditch known as the C. W. A. Drain Ditch No. 2 of the Salt Lake Rosquito Abatement District, said easement being 40 feet wide and projecting 20 feet on each side of the centerline described as follows:

Beginning at a point located 243.3 feet S. 59° 56' 52" W., along the centerline of 17th South Street from the centerline of Swaner Road; thence bearing S. 8° 41' W., 526.0 feet; thence S. 6° 00' E., 1441.5 feet; thence S. 29° 10' E., 156.1 feet; thence S. 0° 24' E., 500 feet, more or less, to the north property line along 21st South Street.

Also, from said point of beginning, bearing N. 8° hl' E., 64.0 feet; thence N. 14° 30' E., 1327.7 feet; thence N. 59° 39' E., 39.6 feet to a point on the centerline of Swaner Road, which point is 299.9 feet southerly from the intersection of the centerlines of Swaner Road and 15th South Street; thence continuing N. 59° 39' E., 49.1 feet, thence N. 0° 45' N., 240.1 feet; thence N. 14° 48' E., 47.1 feet to a point on the centerline of 15th South Street, which point is 51.6 feet easterly from the last said intersection; thence continuing N. 14° 48' E., 979.4 feet; thence N. 1° 19' E., 46.7 feet to a point on the centerline of Swaner Road; thence continuing N. 1° 19' E., 237.7 feet; thence N. 0° 18' W., 1094.7 feet to an intersection with the centerline of the C. N. A. Drain Ditch No. 2.

Drain Piten No. 2 of the Salt Lake Mosquito Abatement District, said easement being 40 feet wide and projecting 20 feet on each side of the centerline described as follows:

beginning at a point in the west property line along Redwood Road which point is 1035.19 feet 3. 0° 03' 03" E., and 80.0 feet S. 89° 56' 52" W., from the Salt Lake city Street anomant of the intersection of said Redwood Road and Califor Ma Avenue; thence bearing N. 46° 59' 14" W., 3514.64 feet to an intersection with the centerline of C.W.A.
