Grant of Right of Way

This Indenture, made the 12th day of July 1899, by and between the First Ward Pasture Company, a corporation, in the County of Utah, State of Utah, duly organized and incorporated under the laws of the State of Utah, party of the first part, and the Utah Sugar Company, a corporation, organized under and by virtue of the laws of the State of Utah, the party of the second, Witnesseth:

That whereas, the said party of the first part is a private corporation duly incorporated and existing under and by virtue of the laws of the State of Utah, and whereas a majority of the stockholders of the said corporation in meeting assembled on the 7th day of June 1899, duly authorized the Board of Directors of said corporation, to convey the property hereafter described, to the party of the second part, and whereas the Board of Directors of said corporation in meeting assembled duly passed the following resolution on the 12th day of July A.
