(Vacating a portion of the Union Heights Subdivision
Pursuant to Petition No. 400-96-93)

AN ORDINANCE APPROVING THE VACATION A PORTION OF THE UNION
HEIGHTS SUBDIVISION, AS REQUIRED BY SECTION 10-9-808, UTAH CODE
ANNOTATED, PURSUANT TO PETITION NO. 400-96-93.

WHEREAS, Petition No. 400-96-93 was filed with the City,
requesting the City to allow the vacation of a portion of the
Union Heights Subdivision; and

WHEREAS, one hundred percent of the owners of the property
within and adjacent to the subdivision have not consented to the
vacation; and

WHEREAS, the City Council has held a public hearing after
giving the required notices and has reviewed the vacation which
has been previously preliminarily approved by the Planning
Commission on May 1, 1997; and

WHEREAS, good cause exists for the vacation of the plat and
the City Council finds neither the public nor any person will be
materially injured by the proposed vacation;

SECTION 1. The City hereby approves the proposed vacation of a portion of the Union Heights Subdivision, described below, as conditionally approved by the Planning Commission on May 1, 1997. The portion of the subdivision to be vacated is more particularly described as follows:


Lots 1 thru 23 and vacated alley of Block 9 and Lots 1 thru 15 of Block 8 of Union Heights Subdivision.
